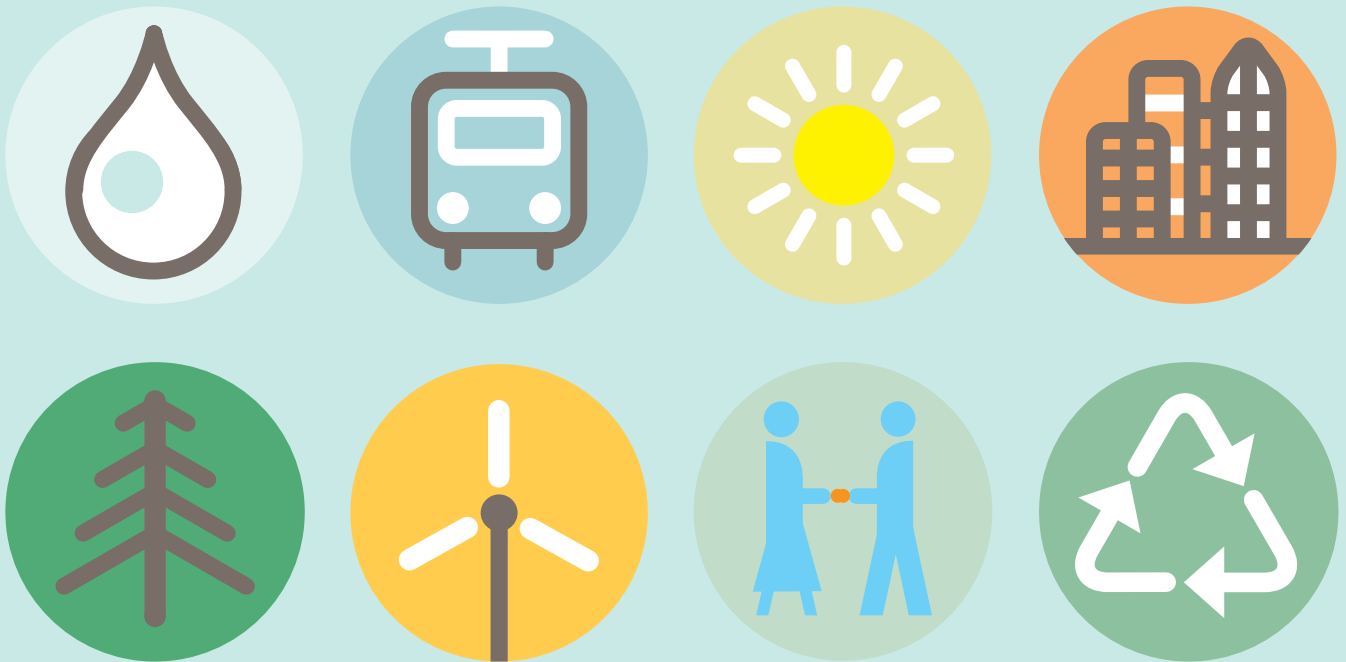

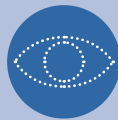

Partnership Data

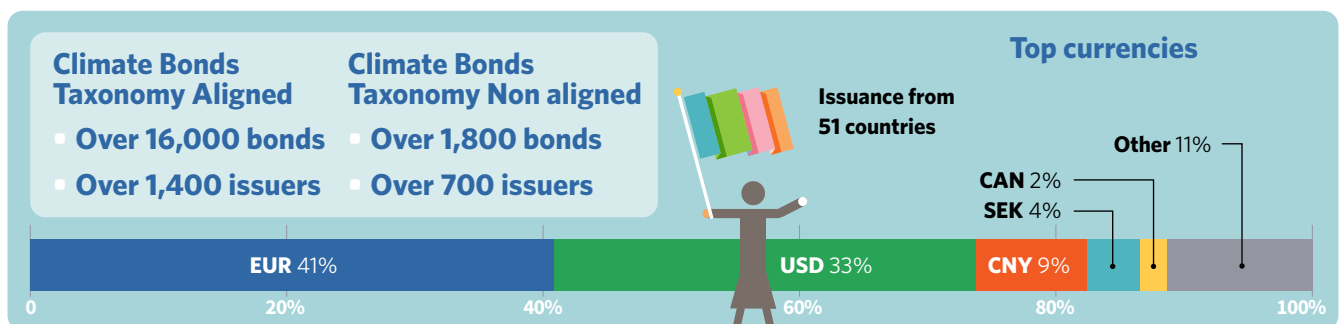
Since 2013, the Climate Bonds Initiative has collected, assessed and provided high quality green bond data to a broad range of global market players such as indices, regulators, stock exchanges, asset managers and asset owners. The Climate Bonds Initiative Green Bond Database has unique features that make it the leading database in the sector.

The Climate Bonds Green Bond Database is a comprehensive list of all labelled bonds (including Sustainability and other labels) with proceeds going to green categories issued since 2007. It is global and includes all currencies, jurisdictions and instrument sizes.



1. Comprehensive sources to identify the labelled bonds, including Climate Bonds regional teams and the network of issuers, external reviewers and underwriters
2. Use of proceeds of each bond is screened against the Climate Bonds Taxonomy
3. An excluded list to show which bonds have been excluded and why
4. Public engagement and commentary to create broader market acceptance of green definitions that are aligned with the Paris Agreement
5. Use of proceeds datapoints provided to filter, categorise and describe each bond
6. Exclusive access to our Partners Portal with data access, interactive graphs and market insights

The Climate Bonds Green Bond Database at a glance:

Screening process

Step 1.

Identification of green bonds.

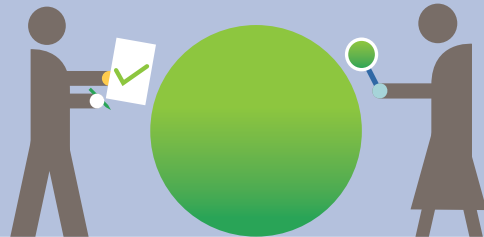
The issuer of a climate-themed bond must declare that the bond is intended to be environmentally beneficial through labelling the bond, ideally as “green”, but other labels are considered.



Step 2.

Screening sectors and green credentials

Each bond or other debt instrument is reviewed based on the green credentials of the use of proceeds. This may be earmarked proceeds for asset-linked, senior unsecured or secured bonds, projects funded by a project bond, or assets backing an ABS or other secured debt. The key is that the asset/project to be financed/refinanced is green.



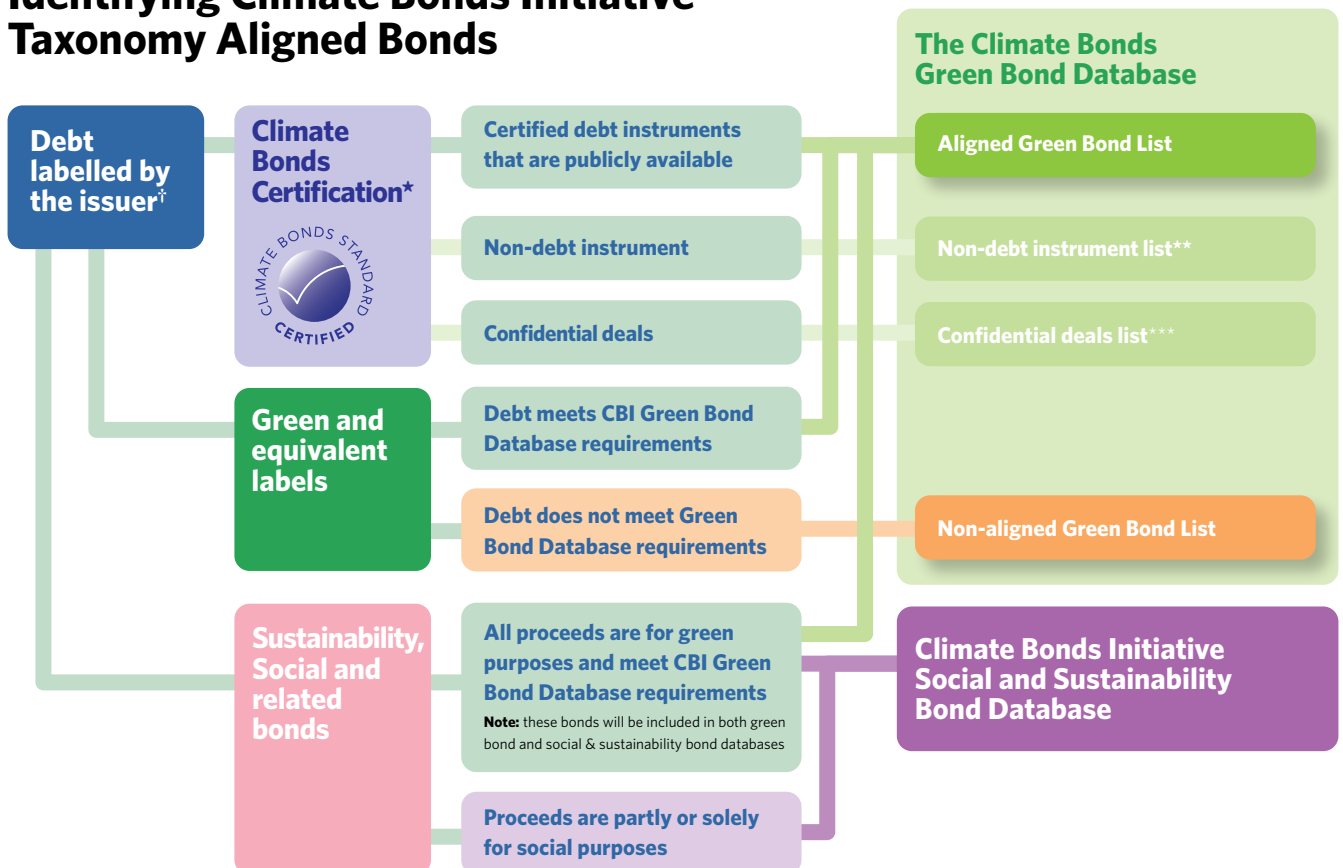
Step 3.

Evaluating the use of proceeds

Climate Bonds Initiative’s focus is on climate-change mitigation, adaptation and resilience. Only bonds which are expected to allocate all net proceeds to eligible green assets, projects and activities are tagged as aligned.
